# **SECTION 3 - HAZARDS IDENTIFICATION**

EMERGENCY OVERVIEW	Brown liquid. Slightly Musty. Sprayed or heated material harmful if inhaled. May cause allergic skin reaction. May cause allergic respiratory reaction and lung injury.
